Letters of Intent

The Town is currently seeking qualified applicants to fill one open seat on its Board of Trustees. This is a crucial opportunity to contribute to the town's growth and well-being. Overgrown & Noxious Weeds

We have many properties in Town with high and noxious weeds. These noxious weeds grow aggressively, multiply quickly, and cause adverse effects through contact or ingestion. The overgrown weeds and dry conditions pose a significant fire hazard. The Town is asking residents to cut overgrown weeds on your property.

2025 Backflow Prevention and Cross Connection

The Town sent out a Cross Connection Identification Survey to all commercial and multifamily housing units who may be required to have a backflow prevention device installed on your water lines. These surveys need to be returned to Town Hall. If you have a backflow prevention device installed, submit proof of most current inspection. It is the customers responsibility to have a backflow prevention device installed if needed and to have it tested annually. It is a violation of Colorado State Law CRS 25-1-114(1)(h) to create or allow a cross connection. If you believe you need a backflow prevention device installed, contact Town Hall. We are putting together a list of certified plumbers that can inspect and install these devices for you.

Utility Rate Increases:

Beginning September 15, 2025, the Town's utility water rates will increase for August 2025 usage as follows:

Stage 3 Water Restrictions

The Town has adopted Stage 3 Water Restrictions (Ordinance 251). **There is no outside watering allowed including watering of lawns/gardens, swimming pools/hot tubs, and washing of cars.** All households and businesses must not use more than 3,000 gallons of water per month. Water meters will be monitored for usage and violators are subject to having their water meters shut off. Ordinance 251 is available at Town Hall or at aguilarco.us.

Monthly Meter Reads

The Town reads water & gas meters the week of the 25th. Please ensure that the Utility Department has access to your meters during this week, so accurate meter reads reflect on your bill. Unlock gates, make sure meters are free from obstructions, and make sure your dogs are not prohibiting the Utility Departments from reading your meters.

Business Licenses

Annual licenses are due for 2025. Licenses are valid from January 1, 2025 through December 31, 2025. Anyone running a business in the Town limits is required to purchase a business license. This includes home based businesses. Applications for business licenses are available online at aguilarco.us or at Town Hall. If you have not yet renewed your business license, please do so now.

Animal Licenses

Annual licenses are due for 2025. Licenses are valid from January 1, 2025 through December 31, 2025. All dogs must be registered with the Town and have rabies vaccinations. Dogs are not permitted to run loose. Applications for animal licenses are available online at aguilarco.us or at Town Hall. If you have not yet renewed your business license, please do so now.

The Town Workshops are held the 2nd Tuesday of the month at 5:00 pm with a Special Meeting following at 6pm at Town Hall. Town Hall meetings for resident comments are held the 3rd Wednesday of the month at 5:00 pm at the Aguilar Community Center. The regular Town Board Meetings are held the 4th Tuesday of the month at 6:00 p.m. at Town Hall.
