Stage 3 Water Restrictions

The Town has adopted Stage 3 Water Restrictions (Ordinance 251). There is no outside watering allowed including watering of lawns/gardens, swimming pools/hot tubs, and washing of cars. All households and businesses must not use more than 3,000 gallons of water per month. Water meters will be monitored for usage. All violators will be ticketed and have their water meters shut off. Ordinance 251 is available at Town Hall or at aguilarco.us.

2025 Drinking Water Quality Report

The Town of Aguilar's 2025 Drinking Water Quality Report for the Calendar Year 2024 is complete. It contains water testing results and information regarding violations, significant deficiencies and formal enforcement orders that have been issued against the Town. The 2025 report is available at Town Hall or at aguilarco.us.

No Dumping Allowed

The Town does not have any dumping sites for branches in Town. There is no dumping allowed at the field near Romero & Linden Street (old branch pile) or at the site off C.R. 43.7. All violators will be ticketed.

Water & Gas Meters

If you need your water or gas meters turned on or off, please call Town Hall to have a work order put in. Residents are not allowed to turn on or off their meters and tampering with water and gas meters is a violation of Ordinance 203. **Any persons caught tampering with water or gas meters will be ticketed.**

Monthly Meter Reads

The Town reads water & gas meters the week of the 25th. Please ensure that the Utility Department has access to your meters during this week, so accurate meter reads reflect on your bill. Unlock gates, make sure meters are free from obstructions, and make sure your dogs are not prohibiting the Utility Departments from reading your meters.

Business Licenses

Annual licenses are due for 2025. Licenses are valid from January 1, 2025 through December 31, 2025. Anyone running a business in the Town limits is required to purchase a business license. This includes home based businesses. Applications for business licenses are available online at aguilarco.us or at Town Hall. If you have not yet renewed your business license, please do so now.

Animal Licenses

Annual licenses are due for 2025. Licenses are valid from January 1, 2025 through December 31, 2025. All dogs must be registered with the Town and have rabies vaccinations. Dogs are not permitted to run loose. **Owners of dogs running at large will be ticketed.** Applications for animal licenses are available online at aguilarco.us or at Town Hall. If you have not yet renewed your business license, please do so now.

Town Hall Meetings

The Town Workshops are held the 2nd Thursday of the month at 5:00 pm at Town Hall. Town Hall meetings for resident comments are held the 3rd Wednesday of the month at 5:00 pm at the Aguilar Community Center. The regular Town Board Meetings are held the 4th Thursday of the month at 6:00 p.m. at Town Hall. If you need to be put on the agenda for the regular meeting, please fill out an Agenda Request Form and submit it and any supporting documentation to the Town Hall no later than the Friday before. Utility Rate Increases

During the June and July Town Hall Meetings, June 18th & July 16th, Kyra Gregory from CDPHE and Sara Everhart from RCAC will be here to explain and answer questions regarding the water utility rate increases that will be going into effect in August 2025. All residents are encouraged to attend and ask questions. The meetings began at 5:00 and are held at the Aguilar Community Center.
