XXI. Discussion Human Resources


Mr. Thorn made a motion that all hiring of employees be done by the Town Board; seconded by Mr. Porras; Mr. Piano voted no; motion passed.

XXI. Approval of Bills


Mr. Porras made a motion to approve the bills from 9/20/2022 through 10/24/2022; seconded by Mr. Piano; motion passed.
